Presentation/Training Descriptions and Fee Scale Effective June 1, 2010

Harbor House Presentation **Length: 15 - 20 minutes**

A Harbor House presentation offers information about Harbor House programs/services and basic domestic violence (Local stats, volunteer opportunities, etc).

Fee: FREE

Dynamics of Domestic Violence (DV 101) **Length: 1 - 2 Hours**

A standard Harbor House presentation is approximately an hour in length. During this presentation, participants will receive a brief overview of Harbor House Services and general information on the dynamics of domestic violence.

Presentations require a minimum of 10 – maximum 20 participants.

Fee: DV 101 - 1 hour – FREE

DV 102 - 2 hours \$10.00 per person

Continuing Education Units (CEUs) \$20 extra per participant

Domestic Violence Workshop **Length: 2 - 4 Hours**

Harbor House workshops offer an in-depth look into the dynamics of domestic violence and resources currently available to assist survivors. Workshops are a minimum of two hours. Workshops require a minimum of 20 participants.

Domestic Violence Training

Length: Full Day

Harbor House trainings offer extensive information about domestic violence, resources and prevention. Participants will engage in discussions to address the issue and explore options to appropriately respond to domestic violence as an individual, organization and a community. Trainings require a minimum of 25 participants.
