

New Outreach Office Now Open

Harbor House of Central Florida is very excited to announce our new central Outreach office! Located at 708 East Colonial Drive, Suite 201, the new office opened earlier this month to serve clients. You are all invited to check it out at an Open House on Thursday, September 13 between 4:30 p.m. and 7:00 p.m. You will have the opportunity to tour the office, hear mission moments from advocates who work in direct service to



domestic violence survivors every day, enjoy light refreshments, and help us stock our pantry.

The new centralized office is a one-stop-shop for survivors in the downtown area. In this office you will find a bilingual Outreach advocate, economic empowerment coordinator, and an injunction for protection attorney.

With free parking, the new office will field referrals from the other Outreach advocates for survivors who cannot afford courthouse parking or who just don't feel comfortable having an initial meeting at the courthouse.

The new office also has a counseling space where community partners can set up to help survivors complete food stamp applications, build resumes, offer child counseling, and more. The possibilities are endless!

Mia* began working with an Outreach advocate at Harbor House in June while her bruises were still healing. Her

We know that abusers who strangle their victims are the ones most likely to eventually kill them. She also recently suffered a miscarriage caused by his physical and sexual abuse.

With encouragement from her advocate, Mia reconnected with

her family. Her boyfriend had isolated her from family and friends and would not even allow her to work. Working with Harbor House's court program, Mia secured a lifetime injunction against her abuser. He is incarcerated, and she is sleeping well in the bed she was able to get from Harbor House community partner Annabel's Closet.

"She was so happy about that bed. She was just crying and overwhelmed," Mia's advocate recounted. "She is looking for employment now and focusing on herself. She is really enjoying her freedom."

As at all of Harbor House's locations, all services are confidential and offered at no cost to clients. This new office will enable us to help more survivors like Mia, equipping them with the tools they need to build a brilliant future.

Message from the CEO, Michelle Sperzel

The past several months I've been given the opportunity to attend more women-focused events - from women's leadership groups to church groups. Each time I attend, I am approached by a woman who either asks for guidance to help a loved one or a woman who shares her personal story of abuse. The conversations are ones of hope, horror, frustration, and strength. Some of the women I speak to confess they didn't call Harbor House but rather sought help from their family, friends, therapist, or church. When I ask why they didn't reach out to Harbor House, the answers are everything from "I didn't need shelter" to "I didn't know what you could do to help me" or "I didn't know it was abuse until my friend told me it was." As an advocate, I know that not everyone will reach out to us for help, but we know if they do they have a better chance of leaving safely and living a life free from abuse. I also know it takes the community to get involved with the local domestic violence organizations to facilitate the

conversations.

Conversations about change are constant. Harbor House's role in the change is creating innovative programs and removing barriers for survivors seeking or receiving services. Many people in the community know Harbor House for our shelter and court services, but not everyone in an abusive relationship needs shelter and not everyone wants to file an injunction. Three of the most valuable services we offer to survivors are safety planning, peer support, and support groups. Over the next year, we hope to help more people in our outreach program through our new downtown office (see cover story). In addition to domestic violence support groups, we are expanding the program to offer support groups for friends and family members of survivors, LGBTQ, male survivors, and children. We will also expand our empowerment workshops to friends and family members. Some of our new workshops will include cooking on a budget, art therapy, basic car

maintenance, understanding the court system, dependency, and budgeting. If you are interested in helping our advocates lead a workshop or you have an idea for a workshop, please let us know. If you want to learn more about how you can help a friend, coworker, or family member who discloses they are being abused. please reach out to us.

Every day, someone's life is changed by domestic violence. Our community is faced with families being held hostage by an abuser as they try to control a survivor. Our own law enforcement officers put their lives on the line whenever they answer a domestic violence call. Every day it affects our community whether we realize it or not.

There is a support network to help, and you are part of it. We need the ongoing financial support and community engagement to innovate programs and provide services. Thank you for being a part of the conversation and for being a changemaker.

A Year at Harbor House

What does a year look like at Harbor House? As we closed out our fiscal year on June 30, we entered data and analyzed reports. We have some impressive numbers to share with you, but the numbers don't tell the whole story.

The real story is about the woman who slept soundly for the first time in years because she secured a lifetime injunction against her abuser. It's about the child who said our shelter is the nicest place he's ever stayed. The numbers don't tell you about the dog who plays happily now instead of cowering in a corner when he hears yelling. The data doesn't explain how hard a mom worked in two short months to rebuild her life—getting a job, securing childcare, buying a car—after leaving everything behind for her own safety and the health of her children.

We didn't do this alone. If you donated money or goods, volunteered, attended events, or shared a Facebook post, you are part of this. Thank you for everything you have done to make these stories possible.
